

**UNION PUBLIC SERVICE COMMISSION**  
**PRESS NOTE**  
**COMBINED MEDICAL SERVICES EXAMINATION, 2025**

The result of the Combined Medical Services Examination, 2025 was declared vide press Note dated 22.12.2025 recommending 812 candidates in order of merit for appointment.

2. The Commission, in accordance with the Rule 13(4) and 13(5) of the Combined Medical Services Examination, 2025, has also maintained a consolidated Reserve List in order of merit below the last recommended candidates.

3. Now, as per requisition placed by the Ministry of Health & Family Welfare, the Commission hereby recommends 30 candidates, which includes, 05 UR, 22 OBC, 02 EWS and 01 SC, to fill up the remaining posts based on Combined Medical Services Examination, 2025. A list of these candidates is enclosed. Ministry of Health & Family Welfare would be communicating directly with the recommended candidates.

4. The candidature of the following 10 candidates is provisional:

5. The offer of appointment to the candidates whose result has been kept provisional will not be issued till the Commission verifies the original documents awaited from such candidates. The provisionality of these candidates will remain valid only for a period of six months from the date of declaration of Reserve List. In case the candidate fails to submit the requisite documents as required by the Commission within this period, their candidature will be cancelled and no further correspondence would be entertained in this regard.
